



## **Exhibitor Liability Insurance Program**

As a standard requirement for all our show exhibitors, it is necessary for you to carry general liability coverage from an insurance company in good standing with minimum policy limits of \$1,000,000 per occurrence and \$1,000,000 aggregate. Insurance Coverage is not optional.

This insurance must be in force during the lease dates of the event, January 17-28, 2025 naming National Association of Music Merchants (NAMM) (5790 Armada Drive Carlsbad, CA 92008) as the certificate holder. The following must be named as additional insured: National Association of Music Merchants, Anaheim Convention Center and the City of Anaheim.

National Association of Music Merchants has requested that Rainprotection serve as their insurance management company. In addition to being able to provide exhibitors with insurance, we are also collecting and verifying that all insurance certificates, regardless of the insurer, are verified for compliance.
